

Minutes of Technical Evaluation Committee Meeting for Evaluation of Technical Bid for Tender No. BMSICL/2023-24/ME-323 held on 11th June 2024 at Conference hall of BMSICL Patna,

1. Attendance- As per the attendance register.
2. Tender for supply, installation & commissioning of Medical Equipment on Turnkey Basis for **Govt. Medical College and Hospital, Chapra (Saran), Bihar** was floated vide Tender No.-BMSICL/2023-24/ME-323. In the TEC meeting held on 10/01/2024 for online opening of technical bid on the website <https://eproc2.bihar.gov.in> successfully submitted bids were found as following:-
 1. M/s Vikas Medical Devices
 2. M/s POCT Services
 3. M/s Sysmed Exim Pvt. Ltd.
3. In the said meeting, it was recommended for evaluation of the technical bid of the above said firms with the help of TE/SRU. Accordingly the firm wise evaluation sheets of technical bids prepared with the help of SRU/TE, were uploaded on the website of BMSICL vide letter no-BMSIC/45025/146-2023/10692, dated:-05.03.2024 for clarification/objection, if any.
4. The clarification /objection received from the bidders were examined by the committee in the TEC meeting held on 15.05.2024 and it was found that the clarification given by most of them are not supported by documentary evidence. In the said meeting it was recommended that these bidders should be given the last opportunity for 48 hours to submit documentary evidence against the clarification through E-mail.
5. The clarification received from the bidders were examined by the committee in the TEC meeting held today, in which the firm wise evaluation sheets (**Annexed as Annexure-I**) of post clarification documents prepared with the help of TE/SRU were examined by the committee and the observations were found as following:-
