

Minutes of Technical Committee Meeting for Evaluation of Technical Bids for Tender No. BMSICL/2023-24/ME-317 held on 26th October 2023 at Conference hall of BMSICL, Patna.

1. Attendance - As per the attendance register.

2. Tender for the Procurement, Rate Contract and Supply of Microwave Based Medical Waste Sterilization System for different Govt. Health Institutions of Bihar was floated vide Tender No.- BMSICL/2023-24/ME-317. In the TEC meeting held on 20/09/2023 for online opening of technical bids on the website www.eproc.bihar.gov.in, successfully submitted bids were found as following:-

4. In the TEC meeting dated 20.09.2023, it was decided to proceed for evaluation of technical bids submitted by M/s Nuzen Associates Pvt. Ltd., M/s Haresh Agencies and M/s S. S. Medical System (I) Pvt. Ltd. with the help of piramal technical expert as per above chart.

The equipment wise/firm wise evaluation sheets of technical bids for the above said tender, prepared with the help of piramal expert cum-SRU, were uploaded on the website of BMSICL vide letter no-BMSIC/45025/129-2023/5706, dated:-06.10.2023 for clarification/objection, if any. The last date to submit the clarification/objection was 16/10/2023.

6. The clarifications/objections, received in the light of that notice, were further examined and a comparative chart was prepared with the help of SRU/TE vis-a-vis the preliminary evaluation sheets. This comparative chart was examined by the committee in today meeting and the observations were recorded as following: -
