- **3.** Accordingly, the demonstration of the equipment namely Laparoscopy System with Hand Instruments and Hysteroscopy System with Camera System was held on 06/12/2023 and 07/12/2023 as per the schedule.
- **4.** The technically qualified firm M/s Vikas Medical Devices demonstrated their quoted model of both the equipment in presence of committee consisting of experts from PMCH Patna, NMCH Patna & BMSICL Patna. The said firm was asked to provide declaration/clarification on 12 points for **Hysteroscopy System with Camera System** which the firm did not provided leading to disqualification for the said equipment.
- 5. The technically qualified firm M/s Heager India Pvt. Ltd demonstrated Laparoscopy System with Hand Instruments on 06.12.2023 but did not demonstrated "Image/Video Recording unit" in Laparoscopy System with Hand Instruments . Also, Hysteroscopy System with Camera System was not demonstrated on 07/12/2023 by M/s Heager India Pvt. Ltd. Thus, the said firm was asked to re-demonstrate both the equipment on 27.12.2023.
- **6.** M/s Heager India Pvt. Ltd. demonstrated "Image/Video Recording unit" in Laparoscopy System with Hand Instruments on 27.12.2023 but did not demonstrated Hysteroscopy System with Camera System.
