

**Minutes of Technical Committee Meeting for Evaluation of Demonstration Report for Tender No. BMSICL/2018-19/ME-103, held on 22<sup>nd</sup> April 2019 at Conference hall of BMSICL, Patna**

2. In the TEC meeting held on 11<sup>th</sup> January 2019, the committee recommended for the demonstration of the following qualified bidders for their respective quoted model of the equipment.

Ltd. demonstrated their quoted model of Bubble CPAP in presence of committee consisting of experts from PMCH, Patna, NMCH, Patna, & BMSICL Patna. The technically qualified firm M/s Phoenix Medical Systems Pvt. Ltd was not able to demonstrate their quoted model of Bubble CPAP due to some technical problem in the equipment.

(ii) The demonstration of the equipment namely **C-Arm Machine** was held on 14/02/2019 and 11/04/2019 as per the schedule. The technically qualified firm M/s Allengers Medical Systems Limited & M/s Dynamic Infra and Services India Pvt. Ltd. demonstrated their quoted model of C-Arm Machine in presence of committee consisting of experts from PMCH, Patna, NMCH, Patna, IGIC Patna & BMSICL Patna.
