## Minutes of the meeting of Financial Committee for Equipment Tender No. BMSICL/2016-17/ME-051, held on 28<sup>th</sup> December 2017 at BMSICL, Patna.

- 1. Attendance: As per attendance register.
- 2. Tenders for the procurement of seven (07) different types of Medical equipment namely (I.) TMT Machine (ii.) Holter Machine (iii.) High End ECHO (iv) Mid End ECHO (v) Physiograph Machine (vi) Polygraph Machine and (vii) ECG Machine (12-channel) for Govt. Medical Colleges and Hospitals of Bihar were invited vide tender no. BMSICL/2016-17/ME-051 through publication of Notice Inviting Tender (Advertisement ID. 12108 vide BMSICL Letter no. 3550 dated 17.01.2017). This tender notice was also uploaded and published on the official website of BMSICL i.e.www.bmsicl.gov.in. and www.eproc.bihar.gov.in. Till the last date of online submission i.e. 11.03.2017 up to 17:00 Hrs.

In the online opening of bids held on 15.03.2017, total of six (06) firms were found having submitted their bids out of which four (04) bids for ECG (12-channel), two (02) bids for Physiograph Machine, two (02) bids for Polygraph Machine and no bids were received for remaining four equipment namely TMT Machine, Holter Machine, High End ECHO and Mid End ECHO Machine.

Hence the technical committee in its meeting dated 15.03.2017 recommended to do re-tender for these four equipment for which no bids were received and accordingly it was decided to re-tender for remaining four equipment namely TMT Machine, Holter Machine, High End ECHO & Mid End ECHO Machine and to go ahead with the bids of rest of equipments.

3. Technical eligibility of the Bids received for ECG (12-channel), Physiograph Machine and Polygraph Machine were evaluated by the Technical Evaluation

Committee with the help of SRU Team. After due deliberations in two meetings dated 10.08.2017 and 21.09.2017 the Technical Evaluation Committee found two (02) firms namely M/s Medicaid Systems. and M/s G. K. Medicals & Engineers qualified for their quoted machines i.e. Polygraph Machine and Physiograph Machine respectively and two firms namely M/s Taurus Healthcare Pvt. Ltd. & M/s POCT Services qualified for their quoted machines i.e. ECG Machine (12-Channel) while Allenger Global Healthcare Pvt. Ltd. was found to be Technically disqualified for non- submission of valid quality standard certificate as per checklist point no. B(13) and M/s Trivitron Healthcare Pvt. Ltd. was found to be Technically disqualified for non-submission of past performance of at least five machines of quoted model with documentary evidence as per ITB Clause 15.2 b(ii) & 15.2 (d) for their quoted machine i.e. ECG Machine (12-Channel).

- 4. After that, demonstration of equipments of technically qualified firm to physically examine their technical specifications, was held on in two meetings dated 15.11.2017 and 16.11.2017. The demonstration committee consisting of experts from IGIC, Patna, for ECG Machine (12-Channel) of both technically qualified firms and experts from PMCH Patna & NMCH Patna examined Physiograph & Polygraph machine of both the qualified firms mentioned above and found them conforming to the specifications mentioned in the bid document.
- 5. From the perusal of demonstration committee report, the technical evaluation committee finally recommended for opening of financial bids of all the qualified bidding firms as mentioned above for the equipment i.e. ECG Machine (12-Channel), Physiograph Machine and Polygraph Machine.
- 6. As per the recommendation of Technical Evaluation Committee dated: 13.12.2017, the financial committee meeting for opening of financial bids of all the qualified bidders was held today as per schedule.
- 7. After opening of the financial bids (Annexure-A), a comparative rate chart was prepared, (Annexure –B). As per the Financial comparative Chart, the rates quoted by all the technically qualified bidders are mentioned below:-
