

**Minutes of Technical Committee Meeting for Evaluation of Technical Bid of Tender No. BMSICL/2019-20/ME-155 held on 12<sup>th</sup> August 2020 at Conference hall of BMSICL, Patna**

In the TEC meeting held on 20/03/2020, the firm wise evaluation sheets of technical bids prepared with the help of TE/SRU, were examined by the committee and recommended to upload the firm wise evaluation sheets on website of BMSICL for seven (07) days for clarifications/objections, if any.
