## REVISED MINIMUM ELIGIBILITY CRITERIA FOR EMPANELMENT OF ARCHITECT CONSULTANT IN BMSICL NIT NO.-BMSICL/INFRA/19/2016, DATED-28.06.2016

The Architect consultant / company should meet the following minimum qualifying criteria for different monetary groups' limits for getting pre-qualified:

Group	Empanelment limit (Project Cost in Crores)	Average Annual Turnover of consultancy fees during the last 5 years (in crores)	Experience of completed consultancy services for similar nature of work during the last five years
Group – A	More than 300 Cr.	5.00	i. Atleast 1 work of 300 Crore ii. or 2 works of 200 Crore each iii. or 3 works of 100 Crore each.
Group – B	More than 100 Cr. Upto 300 Cr.	3.00	i. Atleast 1 works not costing less than `100 cr. ii. or 2 works not costing less than 65 Crore each. iii. or 3 works not costing less than 33 Crores each.
Group – C	More than 10 Cr. Upto 100 Cr.	1.00	i. Atleast 1 work not costing less than 15 crore. ii. or atleast 2 works not costing less than 10 Crore each. iii. or atleast 3 works not costing less than 5 Crore each.
Group – D	Upto 10 Cr.	0.75	i. Atleast 1 work not costing less than 10 crore. ii. or atleast 2 works not costing less than 5 Crore each. iii. or atleast 3 works not costing less than 2 Crore each.
Group- E	Repair and renovation of existing health facility any amount	0.25	i. Atleast 1 work not costing less than 0.5 cr. ii. or atleast 2 works not costing less than 0.35 Crore each. iii. or atleast 3 works not costing less than 0.25 Crore each.

- The applicant must be in existence as consultant for at least 5 years ending the 31.03.2016
- Similar work shall means Institutional building, health related infrastructure projects (construction of hospital buildings both big and small, Healthcare Institutions, Drug Warehouses, ANM & GNM, B.sc Nursing, Para Medical, Schools & hostel buildings etc.)

Note:-1. The last date of submission of EOI is extended from 29 July 2016 at 16:00 Hrs. to 9 August 2016 at 16:00 Hrs.

- 2. Consultant under Group A shall not be automatically be qualified in lower categories. Separate submission is essential for empanelment of lower group i.e. B,C,D,E. However, the technical bid can be submitted in only one envelop clearly mentioning the groups for which application is made.
- 3. The financial proposal (Form I) shall kindly be submitted separately for each of the group. Clearly mentioning the group name on top of the envelop.
- 4. The bidders are requested to submit tender document fee of Rs. 10,000/- for each of the group separately i.e. if any bidder is applying for 4 Groups they have to submit 4 demand draft of Rs. 10,000/- each payable in favour of MD, BMSICL.
- 5. Other terms & Condition for evaluation etc. shall remain same as per original TOR document.
