

Notice Inviting Tender for Rate Contracting for Supply and Erection of Pre-Engineered Building for Various Health Facilities in Different Locations of Bihar

Sealed tender under two bid systems (Technical and Financial) are invited under e-procurement mode for rate contracting for supply and erection of various types of health facility building as green-field project using pre-engineered building technology of **“wall panel of 60 mm thick having density of 40± 2 Kg/Cum with one side 0.60mm thick pre painted galvanized steel sheet (on the outside) and another side 0.80 mm thick pre painted galvanized steel sheet (on the inside). The roof shall also be made of sandwich panel 0.50 mm thick pre painted galvanized steel sheet on both side of puff”** in different locations of Bihar. The facilities which are planned to be constructed in the first stage are as follows:-
