- 7. Bidder desiring to participate in the tender shall have to get registered with e-procurement. Necessary registration forms are available at the website. Bidder will get user id and password by registration. Bidder shall have to obtain DSC (Digital Signature Certificates) also. Bidder shall be able to participate in tender using user id, password, DSC and internet.
- **8.** Bidder shall have to obtain (download) tender papers and submit (upload) their bids only at the website. Prescribed forms filled up at specified places and necessary documents shall be submitted. Information regarding tender opening or any corrigendum regarding tender shall be available at the departmental website and at (www.eproc2.bihar.gov.in) only.
- **9.** Contractor's quoted labor rate in the financial bid should not be below of the minimum prescribed government labor rate. If any contractor violates then his bid will be cancelled.
- **10.** The cost of tender document is non-refundable and it should be pay online by E-payment only. EMD (in original) through only Bank Guarantee shall be submitted at the office of the BMSICL, till date and time of opening of technical bid only online payment as per site.
- 11. Earnest money shall be in the form as explained in the Bidding Document available in Tender free View at the website. One copy of uploaded tender document and Earnest money in original shall be submitted at the office of the BMSICL, Patna, till last date and time of opening of technical bid.
- 12. The Successful bidder in technical bid must have to deposit difference of 2% of total quoted amount as a EMD after opening of Financial bid.ie (Difference amount of EMD to be deposited =2% of Total Quoted amount 10,00,000.00), as per SBD.
- 13. Deduction at source from running bill for Income tax, GST, Seigniorage fee, Labour Cess, Security deposit etc. shall be made as per Bihar Government rule. Rate quoted by bidder all-inclusive taxes for one year.
- **14.** The Process of floating of tender shall be accorded with the rule of BMSICL, Patna and the clauses of standard bidding document.
- **15.** Conditional Bank Guarantee shall not be accepted rather it should be identical of standard format of SBD.
