- (1) The qualification criteria and other conditions can be seen in the Tender Document downloaded from the website of [www.eproc.bihar.gov.in](http://www.eproc.bihar.gov.in).
- (2) The Tender Document should be submitted through e-tendering/e-Procurement portal only. No other form of tender submission will be valid for evaluation.
- (3) For participating in the above E-Tendering process, the contractor shall have to get themselves registered with the service provider so that user ID, Password and Digital Signature are issued to them. This will enable them to access the website ([www.eproc.bihar.gov.in](http://www.eproc.bihar.gov.in)) and download/participate in E-tender. - (4) Tenders duly filled and accompanying all supporting documents, should be uploaded in the e-Procurement/e-Tendering portal as per defined schedule in **Item No.-3**, after which no tender would be accepted. The bidder shall submit their eligibility and qualification details in the On-line standard formats given in e-Procurement website. The bidder shall upload the scanned copies of all the relevant certificates, documents which are necessary to support his eligibility criteria at the e-Procurement website. The bidder shall sign and stamp on all the pages of statements and documents, certificates uploaded by him owning responsibility for their correctness/authenticity. It is also essential to submit one copy of uploaded Tender document in hard copy in a separate envelope, self signed on each paper of the document, for comparing in the office of BMSICL, Patna upto next day after last date of submission i.e. **upto 15.00 hrs on 18<sup>th</sup> July 2014.**
- (5) The cost of Tender Document as mentioned above shall be paid in the form of Bank Draft issued from any Nationalized/Scheduled bank in India and drawn in favour of **MD Bihar Medical Services and Infrastructure Corporation Limited, Payable at Patna.** Original Bank Draft will have to be deposited along with hard copy of Tender document in the office of BMSICL, Patna on or before **upto 15.00 hrs on 18<sup>th</sup> July 2014** failing which tender will be rejected.
- (6) No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last hour's technical snags.

- (7) Corrigendum/Addendum, if any, will be published on the website of BMSICL ([www.bmsicl.gov.in](http://www.bmsicl.gov.in)) and [www.eproc.bihar.gov.in](http://www.eproc.bihar.gov.in).

- (10) If the total amount on the basis of quoted rate by bidder is more than 10% less from the tendered cost, the financial bid of that bidder shall not be accepted.
- (11) The fee of bid processing is to be deposited by the tenderer through net banking i.e RTGS/NEFT/Debit Card. The tenderer must ensure the payment before schedule time otherwise in last moment for delay payment the corporation will not be responsible.
- (12) The required amount of earnest money is acceptable either in form of Bank Draft or Bank Guarantee in proper format issued by Nationalized and Schedule Bank in favour of MD BMSICL, Patna and payable at Patna. The earnest money deposited in any other form shall not be acceptable.
