Technical Committee Meeting for evaluation of Technical Bids of Tender No. BMSIC/10035/11-22/01 ('Tender for providing Uninterrupted Unified Power Supply Backup to BMSICL Office (HQ) at Patna').

With reference to the Notice Inviting Tender (NIT) Reference No.: -BMSIC/10035/11-22/01 "Tender for providing Uninterrupted Unified Power Supply Backup to BMSICL Office", published in leading newspapers (request for which was sent to IPRD vide BMSICL letter no. 6418 dated 08.11.2022) and uploaded on the website "http://www.eproc.bihar.gov.in/ BELTRON", the Technical Committee Meeting for evaluation of the Technical Bids was held on 02/01/2023 at 15:00 hrs at the Patna office of BMSICL.

The following members of the Technical Committee were present in the Meeting:-

The Technical Bids of the following bidders whose bids were received before the stipulated date and time were opened on e-proc on 12.12.2022:

- (i) Vanprastha Infra Pvt Ltd
- (ii) R.K. Infra Services (P) Ltd.
- (iii) R.K. Electric Works
- (iv) Perfect Sales & Services
- (v) Shree Mahavira Buildwell Pvt Ltd

Based on the terms and conditions of the tender, the technical bids were evaluated and the preliminary technical bid evaluation sheet with the bidder-wise observations/remarks were uploaded on the website of BMSICL along with a notice dated 23.12.2022 asking bidders to submit their objections/clarifications with documentary proof by 27.12.2022. Further the bidders were informed vide email also in this regard. Pursuant to the above, only two bidders - Vanprastha Infra Pvt. Ltd and R.K. Electric Works submitted their response/clarification documents vide e-mail. No response was received from the other three bidders.

The Technical Evaluation Committee perused the Technical Bids of all the bidders as well as the documents received from them and based on the terms and conditions of the tender the final evaluation of the bids was done. Post evaluation, the bidder-wise conclusions of the Technical Evaluation Committee is as per the attached Technical Bid Evaluation Sheet and are summarised as below:

- i. Vanprastha Infra Pvt. Ltd The bidder has submitted all documents in accordance to the terms and conditions of the tender. Hence the bidder was considered as technically qualified.
- ii. R.K. Infra Services (P) Ltd. Against the eligibility criteria clause 2 iv of the tender, the bidder has submitted only one work order dated 25.3.2022. No contract or experience certificate for any other year has been attached; hence experience for last 3 years is not proven. On account of the above, the bidder is technically disqualified.
- iii. R.K. Electric Works The bidder has submitted all documents in accordance to the terms and conditions of the tender. Hence the bidder was considered as technically qualified.
- iv. Perfect Sales & Services The Demand Drafts against the EMD and Tender Fees submitted by the bidder are not in accordance to the clause 3 (a) of the tender as neither the bidder nor the proprietor is the applicant for the Demand Drafts. Further against the eligibility criteria clause 2 iv of the tender, the bidder has submitted only one work order dated 06.05.2020, no contract or experience certificate has been attached; hence experience for last 3 years is not proven. The bidder has also not submitted any document in accordance to the clause 3 (d) of the tender. Hence the bidder is technically disqualified.
- v. Shree Mahavira Buildwell Pvt. Ltd. Against the clause 3 (h) of the tender, the bidder has submitted Income Tax Return (ITR) for only one Assessment Year 2022-23. Balance two years ITR have not been submitted by the bidder. From the documents submitted in support of experience, the duration is not clear. Hence the bidder is technically disqualified.

Based on the above, the Technical Evaluation Committee recommended the two bidders - Vanprastha Infra Pvt Ltd and R.K. Electric Works as responsive and technically qualified. The Technical Evaluation Committee recommended the opening of the Financial Bids of the above two technically qualified bidders.
