

Minutes of Financial Evaluation Committee Meeting for tender no. BMSICL/2017-18/WH-01 entitled as "Rate contract and supply of Plastic Pallets, Slotted Angles Racks, Platform Hand Truck & Manual Hydraulic Stackers for Drug Stores in Bihar" on 12th September, 2018 at 15:30 hrs. in BMSICL Conference Hall, 4th Floor, Bihar State Building Construction Corporation Ltd., Hospital Road, Shastri Nagar, Patna.

1. **Attendance:** As per Attendance register.
2. Bihar Medical Services & Infrastructure Corporation Limited (A Govt. of Bihar Undertaking) has invited bids vide reference number: BMSICL/2017-18/WH-01 for the Rate contract and supply of Plastic Pallets, Slotted Angles Racks, Platform Hand Truck & Manual Hydraulic Stackers for Drug Stores in Bihar. The bid document was uploaded on BMSICL Website & www.eproc.bihar.gov.in and the NIT was published in newspapers through IPRD vide letter No. BMSIC/55015/02-2017/4381 dated 02.02.2018. The last date for submission of online bids was 16.03.2018 up to 3:00 PM and the tender was opened online on 19.03.2018 at 3:30 PM. In the online opening it was found that following four bidders have participated for the rate contract and supply of Plastic Pallets, Slotted Angles Racks, Platform Hand Truck and Manual Hydraulic Stackers for Drug Stores in Bihar:

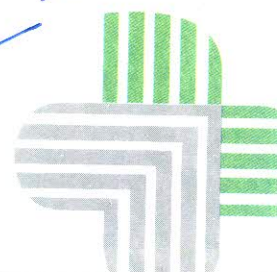

The second meeting for technical evaluation was convened on 03rd August, 2018 wherein it was observed that the bidders namely M/s Daccess Security System Pvt. Ltd. & M/s Newgen Specialty Plastics Ltd. fulfilled the bid criteria and as such the abovementioned bidders were found to be technically qualified and the bidders namely M/s Nilkamal Limited & M/s Vishakha Industries were found to be technically disqualified. The qualification status of the bidders was recorded as follows:
