## MINUTES OF TECHNICAL EVALUATION COMMITTEE MEETING FOR EVALUATION OF BIDS VIDE TENDER NO.: BMSIC/QC/01/2023 (ONLINE TENDER FOR EMPANELMENT OF DRUG & SURGICAL TESTING LABORATORIES FOR ANALYSIS OF DRUGS & SURGICAL ITEMS FOR A PERIOD OF THREE YEARS)

The Technical Evaluation Committee (TEC) Meeting for evaluation of bids, under Tender No. BMSIC/QC/01/2023, was held on 30<sup>th</sup> May 2024 at 15:00 Hrs, under the Chairmanship of Dr. Sunil Kumar Jha, Director in Chief, Department of Health, GoB. Other committee members present at the meeting were:-

## **Attendance:** As per attendance register.

Bihar Medical Services & Infrastructure Corporation Limited (A Govt. of Bihar Undertaking) has invited Tender number: BMSIC/QC/01/2023 Dated 07.11.2023 for "Online Tender for Empanelment of Drug, Food & Surgical testing laboratories for analysis of Drugs & Surgicals items for a period of three years". The tender advertisement was published in various leading national Newspapers. Online tender was also uploaded on <a href="www.eproc2.bihar.gov.in">www.eproc2.bihar.gov.in</a> and BMSICL Website.

A total of nine (09) bidders submitted online bids within the stipulated time. During the opening of technical bids on 07-12-2023, it was found that M/s Multani Pharamaceuticals Ltd. had not submitted the hard copy of the Earnest Money Deposit (EMD) in the form of Bank Guarantee (BG), but had instead submitted the EMD amount online on eproc2, which is not in accordance with the tender condition. Therefore, the firm M/s. Multani Pharmaceuticals Ltd. stands disqualified. The remaining 08 bidders have successfully submitted their bids and are qualified for technical evaluation as follows:

The Preliminary Evaluation sheets of aforementioned laboratories were reviewed in the meeting on dated 23<sup>rd</sup> February 2024. Evaluation sheets were published on the eproc2 and BMSICL website, and claims, objections or clarifications were invited online vide notice no. 10799 on dated 07/03/2024 on e-proc2.

After evaluating the clarification received from the bidders in response to the notice and closely examining the documents submitted by the firms, the technical evaluation findings for each firm were recorded in the meeting as follows:-

As per approval three teams (two members each) of Drug Inspector were constituted for physical Inspection of laboratories which are technically qualified. Physical verification was carried out by the constituted teams of Drugs Inspectors.

The physical verification reports submitted by the team members were put up before the technical committee members in meeting which was held on 30<sup>th</sup> May 2024 for perusal, the summary of which were found as follows:-
