The Technical Evaluation Committee Meeting for review and evaluation purpose vide Tender No. BMSIC/QC/01/2020 was held on 09<sup>th</sup> March 2021 under the Chairmanship of Dr. Navin Chandra Prasad, Director in Chief, Department of Health, GoB. Bihar Medical Services & Infrastructure Corporation Limited (A Govt. of Bihar Undertaking) has invited Tender number: BMSIC/QC/01/2020 Dated 23.07.2020 for "Online Tender for Empanelment of Drug & Surgical testing laboratories for analysis of Drugs & Surgical items for a period of three years". Tender advertisement was published in various Newspaper in leading national newspapers in the following editions of Delhi, Chandigarh, Haryana, Hyderabad, Mumbai, Kolkata, Chennai, Bangalore & Bihar edition of major vernacular/Hindi Newspapers. Online tender was also uploaded on www.eproc.bihar.gov.in and BMSICL Website.

Total sixteen bidders submitted online and hard copy within the scheduled time.

During the opening of technical bids on 15-09-2020 it was found that M/s. Interstellar Testing Centre Pvt. Ltd. has submitted the EMD fee but not submitted the tender fee, hence it was unanimously recommended for considering only following 15 bidders who have successful submitted their bids online as well as offline, for further Technical Evaluation process and not to consider, M/s. Interstellar Testing Centre Pvt. Ltd. for further Technical Evaluation as it was found disqualified for that reason.
